**Please Read The Following Carefully:** Your participation is VERY important to the Damascus Shrine Cruise Nights. Since this is a weather dependent weekly event, there are NO refunds for any reason.

**Rules for Vendors:**

- You must have all necessary permits, ON SITE with you every week.
- You must submit your menu for approval with this form. The Damascus Shrine Cruise Night reserves the right to limit the menu items food vendors will be allowed to sell.
- Failure to have proper licensing, etc. will result in banishment from the Damascus Shrine Cruise Nights for the balance of the season, and will be reported to the proper authorities including the Webster Police Department immediately (NO refunds on fees paid).
- You will maintain AT LEAST, one working fire extinguisher (suitable for Class A & B fires) and one large trash can, with liner, for patrons refuse. You are responsible for cleaning your own area at the end of each cruise night.
- You will be assigned an area for your vending each week.
- The Damascus Shrine Cruise Nights will provide electricity, however Extension Power Cords must be provided by you.

This year the Cruise Night will not cancel due to weather conditions. Instead, we will remain open with our full menu available. We are encouraging the car owners to bring out their everyday cars during bad weather and still join us for dinner. It will be up to you whether you want to set-up on bad weather days. I have read, and understand the Vendor Rules, as written, and agree to abide by them, in total. I also agree to be in compliance with every applicable Federal, State and Local law, as it applies to my business. I realize that failure to do so may result in my banishment from the Damascus Shrine Cruise Night, for the balance of the season. I also realize that there are NO refunds for any reason. I realize that the Damascus Shrine Cruise Nights are a place to promote the Webster and Rochester, NY area, in general, and my business, in particular. I promise that the conduct of myself and my employees, will always strive to further the "Caring Attitude" that the Damascus Shrine Cruise Nights have maintained. I also realize this is a NON-renewable agreement and future participation is at the Sole Discretion of the Damascus Shrine Cruise Night Chairman and Committee.
